The following information must be completed to apply for a Fireworks Display License:

Proof of Identification – Applicant

For purposes of proof of identification, the "applicant" shall mean the natural person signing the application for a Fireworks Display license)

	A valid driver's license or identification card issued by Minnesota, another state, or province of Canada, and including the photograph and date of birth of the license person
	A valid military identification card issued by the US Dept. of Defense
	A valid passport
	If birthplace was not in the U.S., provide a Certificate of Naturalization, Certificate of Citizenship, or current U.S. Passport
	If not a U.S. Citizen, provide proof of immigration / employment status

Other Business/Insurance Documents Needed:

	Applicant name and business name; fireworks company if involved
	Proof of general liability coverage; must cover date(s) of sales plan
	Fireworks data sheet, if necessary to outline product to be sold
	Site plan displaying the layout of the premises where fireworks will be sold; must include exactly where sale display will be located and where fireworks will be stored.
